Merchandise Site Information

V8 Supercar Championship Series Rd 7 – July 18-20, 2008

- Full payment of site fees is required with your application form. Payment may be made by cheque, credit card (Mastercard, Visa and American Express Card) or by direct credit to Rev City NAB bank account BSB 084-911 A/C 5900-11438.
- A certificate of currency for Public Liability Insurance / Workers Compensation Insurance cover must be supplied with the application. **The policy must include Qld Raceway and Ipswich City Council as interested parties.**
- Merchandising space is very limited, therefore there will be no car parking available in the merchandise area for merchandiser's vehicles. Parking for merchandisers cars will be located approximately 300m away in Car Park 1. Prime movers will have to be parked in central car park. All cars **MUST BE REMOVED** from the Merchandise Area before **3pm** on Wednesday 16th July. This will be enforced by our security and the Police. All unattended vehicles will be towed away at their owner's expense.
- All merchandising sites will be allocated at the direction of the Promoter (Rev City). Site bookings will be confirmed by 6th July 2008.
- Most sites will be located on hardstand areas. NO pegs may be driven into the bitumen, please supply your own ballast for tents/marquees.
- To assist with positioning of your site, please include with your application a diagram/sketch of your proposed layout including dimensions of your display. Details of the proposed use would also be helpful (eg what are you selling/rides etc) to avoid conflicts. The size of your site must include all operating needs – tailgate opening, annexes, walkways – if you setup oversize, additional charges will apply. Prime movers will have to be parked in central car park. .
- Details of available on-site security services and facilities will be forwarded with your site confirmation. These services are not included in site fees and are by private arrangement.
- Site fees includes 2 x 3 day passes including access to the Paddock area for salespersons and one (1) vehicle pass to Car Park 1. Additional Passes are available for purchase at 50% discount to the normal rate when ordered with this application, otherwise normal gate admission fees will apply.
- **Please note Queensland Police** will be enforcing a heavy vehicle embargo departing Queensland Raceway until 7pm on Sunday 20th July. Heavy vehicles departing before this time have been fined \$1500 by the Police. This is a public safety and traffic management requirement.
